

RESOLUTION NO. 2020 – R- 44

A RESOLUTION OF THE CITY OF PALATKA, FLORIDA, AUTHORIZING THE MAYOR TO EXECUTE A TD GREEN SPACE PLANTING & DISTRIBUTION AWARD AGREEMENT WITH THE ALLIANCE FOR COMMUNITY TREES, A PROGRAM OF THE ARBOR DAY FOUNDATION AND TD BANK AND AMEND THE FY 2019-2020 BUDGET ACCORDINGLY

WHEREAS , the City was awarded a \$20,000 grant from the Alliance for Community Trees, a program of the Arbor Day Foundation and TD Bank; and

WHEREAS, the Green Space Planting & Distribution Grant requires no match; and

WHEREAS, the Palatka City Commission finds that acceptance of the Grant, is in the best interest of the City of Palatka and its citizens; and

WHEREAS, the City of Palatka deems it reasonable and necessary to amend the FY 2019-2020 budget accordingly.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF PALATKA, FLORIDA, that

1. the Mayor is hereby authorized to execute the Green Space Planting & Distribution Grant; and
2. That the City Manager and or his successor is authorized to execute grant related documents necessary to complete the grant requirements; and
3. To allow for grant to be appropriately reflected in the budget, the revenues and expenditures of the City of Palatka Better Place Fund Budget for the Fiscal Year 2019-2020 are amended as follows:
